1. CONTENT AND COMPLIANCE.

This is configured as the Cookies Policy (hereinafter, referred to as "Cookies Policy") applicable to the website **www.cvhinmobiliaria.com** (hereinafter, the "**Website**"), enabled mainly to know the properties whose marketing order for sale and / or rent has been made to D^a. 3. DEFINITION AND OPERATION OF COOKIES.

A "cookie" is a file that is downloaded to your computer, smartphone, tablet or television when you access certain web pages in order to store data that can be updated and retrieved by the entity responsible for its installation.
